Norfolk County Council (Potter Heigham) Temporary Traffic Regulation Continuation Order 2023 Road Traffic Regulation Act, 1984 Section 14(1)

ORDER (NTRO6190) continuing the prohibition of the use by the public of footpath the Potter Heigham FP18 from its junction with U19190 Mill Road to its junction with Potter Heigham FP17 in the PARISH OF POTTER HEIGHAM (hereinafter referred to as the said footpath).

- 1. Whereas the Norfolk County Council as Traffic Authority for the Administrative County of Norfolk is satisfied that:-
 - (i) bridge repairs continue to be required at the said footpath and:
 - (ii) that in consequence, use of the said footpath should continue to be prohibited with effect from 1st to 31st March 2023 (previously 20th December 2022 to 28th February 2023) for the duration of the works expected to be about 31 days within the period.
- 2. This Order has a maximum duration of 6 months and will be revoked upon completion of the works. Where exceptional circumstances are encountered during the performance of the works specified in this Order the operational period of this Order may become extended to allow completion of the works after obtaining consent of the Secretary of State.

NOW THEREFORE the Norfolk County Council DO HEREBY ORDER, that with effect from 1st to 31st March 2023 for the duration of the works the said footpath SHALL CONTINUE TO NOT BE USED by the public.

If necessary, the restriction could run for a maximum period of 6 months from the date of the Notice.


Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
