MINUTES February 2024

Minutes of the meeting of Potter Heigham Parish Council held on **Wednesday 10th February 2024** at 7.30pm in Potter Heigham Village Hall.

- Present: Sheridan Turner, Chair Donald Pickering, Vice Chair Helen Bartlett, Councillor David Bland, Councillor Stan Chapman, Councillor Robin Graves-Morris, Councillor Mary Haslam, Councillor Harry May, Councillor Bev Standen, Councillor
- In Attendance: Richard Price, County Councillor Harry Blathwayt, District Councillor
- 1)Apologies: Keith Lowes, Councillor James Stone, Councillor Laura Bateman, Parish Clerk

2) Public Forum

- a) Items from the public None
- b) Items from the County Councillor Concern was raised about appropriate timing of when the Herbert Woods barrier is closed. Cllr Price has purchased CCTV to monitor the flood barrier to be mounted outside Lathams. Camera direction can be selected by the flood wardens and Cllr Price. It was noted when the barrier is late going up, water that is then supposed to be released slowly is being released too quickly. Cllr Price was thanked for purchasing the CCTV.

Cllr Price noted that he has asked Highways to put more grips into the Causeway in Repps. Recent grips dug into Marsh and Church Roads do not reach the ditches. Exact locations of ineffective grips should be sent to the Cllr Price using What Three Words

ACTION: CIIr Standen and CIIr Haslam to report

c) Items from district Councillor

Broadland Futures Initiative (BFI) has been working on issues facing the broads and there will be decisions to be made in the future by the parish council regarding these matters. Considerations will be needed about dredging the river, which would result in more salt water, verses not dredging which would mean higher fresh water levels. Decisions in where to build and what to protect and what not to protect will be needed. High density areas are receiving preference over rural areas with ideas to build resilience into housing to protect against flooding.

Cllr Blathwayt was lobbying Parliament last week, with the IDB Special Interest Group hosted by Liz Truss, pushing for more funding from the government.

Enforcement officers have visited the garage on Bridge Road for inspection and outcomes will be forthcoming.

- d) Items from outside bodies
- i. The Village Hall Management Committee met on 6th February. Salient points were the potential for a table tennis club; the CCTV system is being replaced with better cameras; there is a funding opportunity through the National Lottery Fund to support a Ball wall, but a community interest must first be identified; proposals to replace the outside doors are under review; new internal doors to the hall will be installed shortly; there are continued issues with EON; the Warming Centre Soup and Chatter programme is going well and as per previous minutes, the Village Hall foresees capital repairs that will cost £20-25K. The sewage system constantly needs rodding and ClIr Blathwayt noted unusual occurrences of new springs appearing due to excessive rainfall which could be impacting the system. There will be a public meeting held on 19th March to discuss proposed changes to the Village Hall Constitution to bring it up to date.

3) Declaration of interest

a) Cllr Pickering, Cllr Chapman, Cllr Graves-Morris, Cllr May, Cllr Turner declared an interest in the village hall as they are trustees.

4) Minutes of the last meeting

The following amendments were agreed to the draft January minutes which will be signed at the March meeting.

- i. Section 8: Remove description of grants line as 'village hall' and leave as generic 'grants' line.
- ii. 2c, 2nd sentence: 6 flood warning areas make up one flood alert area, and spelling error on Wayford Bridge
- iii. 3a: Replace Cllr Haslam with Cllr Chapman

5) Matters Arising

Although the Council at the January meeting determined it had no authority over the Falgate re noise and lighting, Cllr Standen visited them as a member of the Parish Council. It was noted that the council had previously agreed not to do this. Cllr Standen reported the football pitch is being changed into a car park and bright lighting is required by the liability insurance. There has been one event since Christmas and it is believed the noise is coming from a private individual. The letter to be distributed to local residents will have the reference to the Falgate removed, providing generic advice as to how to report **ACTION Clerk**

Stickers stating "litter and dog waste only" will be printed.

ACTION CIIr May

There was no update on the changing of the traffic light pattern.

ACTION: Cllr Price to pursue Highways

6) Flooding matters

Cllr Turner requested that councillors email the clerk with their thoughts regarding the flooding so the draft letter regarding flooding can be developed further.

Cllr May stated that farmers are no longer allowed to pump and questioned what provision is being made for storing the extra water. He also questioned what is being programmed into the modelling because the answers are not correct and where are the errors coming from. Cllr Blathwayt stated that it should be discussed at the next Upper Thurne meeting by Broadland Future Initiatives. He stated that the Bure Loop is man made from the 1600-1700's. The 2002 Bessel Scheme was done to stop flooding at Ash farm and to protect A47 and railway line. Great Yarmouth Borough Council do not want any changes to the engineering that might affect A47 or the railway.

Deadline 20th February and to include Andy Buchanan

ACTION CIIr May to contact Andy Buchanan

Cllr Blathwayt stated the National Farmers Union are pushing for the banks to be raised by 50cm so pumping out of flood plains into rivers will not cause them to overflow again. Henry Cator suggested dredging but was wrong about Somerset levels because they've slowed the river and put in more holding devices in the uplands to slow the water reaching to flood plain. Barrages are too expensive for Great Yarmouth and Lowestoft

7) Clerks Report

New Dog bin has been installed but in the wrong place.

ACTION Clerk to follow up

The Boardwalk repair has been done but very poor quality as it is not stable.

ACTION Clerk to follow up

Signs in Market Road are still facing the wrong way

ACTION: CIIr Price follow up with County

The Hedge has been cut on A149 but is now hazardous in that very sharp branches are now prominent.

Trees on Market Road and by Redroofs are hazardous if they fall down will come across the road. ACTION Clerk to report

A boat is needed to go under Potter Heigham bridge to check if there is damage following reports that it is crumbling.

8) Planning Matters

- a) An update from Cllr Blathwayt regarding planning enforcement action at Glebe Farm was noted. The Gym has reverted to permitted hours however there are still visitors there on weekends. Enforcement notice has been served. There is a three month compliance period as the refusal to store commercial vehicles on site is not being appealed. The Annex link will be completed by the end of summer.
- b) New applications received

PF/24/0010 1 Green Lane NR29 5LP . There was no objection from the council.

The Planning Inspectorate will hold a virtual hearing on 4th March to discuss the flooding concerns raised in objection to the planning application on the Bridge Hotel site. It was determined there is no need for Potter Heigham to attend and leave with Broads Authority who will be advocating dismissal of the appeal.

- mindful that the site is said to be in Flood Zone 3b, the circumstances iii. around the POT1x3 allocation in the Local Plan for the Broads, and it being found to be sound;

the implications of the POT1x3 allocation for this development. iv.

To this end, the Inspector requests the following be submitted by 5pm on Wednesday 21 February

- a) any evidence presented to the Local Plan examination around the allocation of POT1x3, together with any sequential testing that was undertaken, any advice from the Environment Agency or similar concerning the allocation, and any other background evidence that informed the allocation;
- b) any comments made by the Examining Inspector on the allocation.
- c) any factual information that has not already been presented but would assist in discussions around points (i) and (ii) above.

The Inspector also requests that, by that date, a suggested condition be submitted to secure the measures proposed that are intended to safeguard residents from flooding. Otherwise, he does not anticipate further information to be needed at this stage.







Dear Chairman and Council Members,

Re: Norwich Western Link Road

We hope this letter finds you in good health.

Today, we write to you with deep concern and a sense of urgency regarding the proposed construction of the Norwich Western Link Road. As representatives of our local communities, it is crucial that we come together and voice our in reservation of this project.

Recent revelations have brought to light a significant funding disparity between Norfolk and Suffolk when it comes to essential infrastructure repairs, such as pothole maintenance. This raises a fundamental question: Is it justifiable to allocate hundreds of millions of pounds towards a new road for the benefit of those living close to Norwich while neglecting the pressing needs of Norfolk's wider communities? We cannot allow our roads to crumble and continue to present a risk of injury and damage to road users.

There are numerous other issues at local levels that require immediate attention. For instance, pedestrian safety is a major concern, with inadequate crossings and a lack of measures to protect pedestrians from speeding vehicles.

Additionally, our public transportation routes are insufficient, leaving many residents with limited access to essential services and opportunities. The provision of mobile libraries is also lacking, depriving our communities of vital educational and cultural resources.

These pressing local matters deserve attention and funding, which could be redirected from the enormous budget allocated to one infrastructure project that will only benefit a very small portion of the County's population.

Furthermore, we cannot ignore the lack of resources dedicated to preventing flooding and coastal erosion. While climate change remains a critical issue, it is essential to focus on the immediate day-today needs of our communities. We must ensure that our resources are directed towards protecting our homes and livelihoods from these natural threats. By investing in flood prevention measures, we can safeguard our communities and mitigate the potential devastating effects of climate change.

The exorbitant cost of the Road cannot be overlooked, especially considering its impact on each individual living in Norfolk. According to the 2021 census, every man, woman, and child in Norfolk would contribute approximately £300 towards this road. In a time of financial strain and rising living costs, it is crucial to question whether it is fair to burden families in our local communities with such a significant expense. The funds earmarked for this road could be allocated to more immediate and essential needs, such as healthcare, education, and social services, which would benefit a broader segment of the population.

Norfolk CC already has large public sector loans which consume a substantive amount of council tax collected each

year. This is set to increase if the project progresses with inevitable further cost hikes requiring the council to make capital borrowing, a further burden on council tax payers.

Moreover, we must not underestimate the long-lasting consequences of destroying one of Norfolk's most beautiful spots, the Wensum Valley. The construction and operation of the Road would irreversibly damage this cherished countryside, which holds significant ecological value and provides a tranquil retreat for residents and visitors alike. Preserving our natural heritage should be a priority, and we cannot let the pursuit of saving a few minutes of travel time come at the expense of our environment and the well-being of future generations.

Many of our communities suffer with rat running and we support measures to promote the

peaceful enjoyment of our homes and communities. Largescale road schemes don't achieve that, are not available to most of us and the resources they consume means money is not available for sensible local traffic management schemes, calming, speeding enforcement and better public transport. Large scale schemes damage our environment, use land that has been used for agriculture and often opens the way for back door development.

Town and parish councils are crucial voices for local interest. We hope you will use your voice and rally local opinion against this financially and environmentally damaging road that will serve few beyond Norwich but we will all pay for.

Together, we can ensure that our concerns are heard, and that the interests of our rural villages are not overshadowed by the ambitions of politically driven projects. Let us be the catalysts for change and the advocates for our communities.

We kindly ask for this email to be circulated to your fellow council members and for the content to be discussed at the next council meeting. We shall, we should mention, be making this engagement known to the local media.
